NOTICE TO ALL PERSONS PARTICIPATING IN SUMMER GROUP ACTIVITIES  
WAIVER OF LIABILITY**

Recreational activities, summer camp activities and athletic programs could involve risk of injury, property damage, and other dangers associated with participation in such activities.

Each participant in such activities should realize these inherent risks and the potential hazards associated with the preparation and travel related to such activities at the College.

It is the sole responsibility of each participant to participate only in those activities for which he/she has the prerequisite skills, qualifications, preparation and training.

The undersigned acknowledges that Reinhardt College does not warrant or guarantee in any respect the competency or mental or physical condition of any trip leader, vehicle driver, or individual participant in any athletic, recreation or summer camp activity.

All participants or their authorized representatives in summer camp, recreational activities and athletic programs are required to sign the Release, Waiver of Liability, and Covenant Not to Sue statement below.

I acknowledge that I (or the person I am authorized to represent) am solely responsible for any hospitalization or other costs arising out of any bodily injury or property damage sustained through my participation in such voluntary athletic, recreational or summer camp activities. The undersigned hereby agrees that for the consideration of Reinhardt College allowing the undersigned to participate in athletic and recreation activities, on certain equipment, facilities, grounds or with personnel of the College, the undersigned participant does hereby waive liability, release and forever discharge the College, its members individually and its officers, agents and employees of and from any and all claims, demands, rights, suits, and causes of action of whatever kind or nature, arising out of all known and unknown, foreseen and unforeseen, bodily and personal injuries, damage to property and the consequences thereof, including death, resulting from participation in or in any way connected with such recreational programs, athletic or summer camp activities.

I further covenant and agree that for the consideration stated above I will not sue the College, its members individually, its officers, agents, or employees, for any claim for damages arising from my participation in or in any way connected with such recreational programs, athletic or summer camp activities.
